Minutes

1. Introductions and Welcome

The meeting was called to order at 3:06 pm by CM Mapp. Everyone introduced themselves and quorum was established.

2. Review/Approve November 2nd 2022 DRAFT Agenda – VOTE

The November 2nd 2022 DRAFT Agenda were reviewed and approved by consensus.

6. HCAP Report

• Stephen Spano was not present to report on HCAP. Council Members reviewed HCAP report on their own time.

7. Needs Assessment Update/COLA Targets

- CS Perez stated that there was not much to report as it is continually difficult to get participants for needs assessment. Finding it difficult to get focus groups together.
 - CS Jordan emphasized it is hard to get folks to participate, expressing an understanding as to why
 it is difficult. Frustrations stemming from lack of response and high turn-over from providers,
 causing a lack of consistency. Also, the transition of CS roles added a layer of difficulty.
- CM Manuel asked if we are able to reach out to medical providers to get more clients/patients to participate.
 - o CS Jordan answered that it is not possible to contact service providers as it would violate HIPAA.
 - CS Jordan clarifies the process of how to gather participants through referrals from service providers or folks opting in on their own through drop-in services. As drop-in services are increasing, CS Jordan notes that folks are not coming in. A plan to re-asses strategy is mentioned.
- CM Mapp asks what populations we are looking at for current needs assessment.
 - o CS Jordan answers we are asking PWLH in general. CS Jordan expresses we owe our due diligence to the most vulnerable populations; Transgender, Latinx, and others not specifically stated.
- CM Sullivan asks if we are able to recruit from the 4th floor Polk street location.

- CS Jordan answers that no referrals are coming in, and expresses that the providers are not engaging patients to encourage them to participate in COLA. Flyers are potentially not being passed out or picked up potential participants.
- CS Perez echoes that the follow through to get a focus group together from these providers is lacking.
- CS Jordan asks what staff can do in order to ensure the mandate of a needs assessment is fulfilled as the challenges of getting COLA reports and needs assessment as stated above.
 - o CM Sullivan asks for clarification on the exact deadline for HRSA's ask of the needs.
 - CS Jordan answers that HERSA is fairly understanding since this issue is happening across other orgs.
 - o CM Mapp offers a social for SFAF Translife, to see if folks want to participate from that group.
 - o CM Thomas offers contacts from SFAF Translife to help facilitate.
- Pushing back needs assessment COLA targets to February is discussed and approved by consensus. An emphasis to gather as much quality information as possible.
