 - o Spano responds that the goal isn't to get the client back into the facility at the moment.
- Spano reviews a client's case where HCAP is supporting the client by creating a trusting relationship between the client and service provider. Client was without HIV medication. Spano updates the group that HIV medication was received after this report was created.
- Spano displays a client's case where the client was potentially be denied food service due to some behaviors the client expressed. Though the service provider had grounds to not allow this client to receive services, they instead reached out to HCAP and expressed the clients need for additional services to better support their access to other services and care. The client is now stably connected to food services.
 - o CM Mapp comments on how great it is that the service providers reached out to Spano.
