### **Minutes**

#### 1. Call to Order and Roll Call. Introduction of Members of the Public.

The meeting was called to order at 4:03 pm by Co-Chair Knoble. Roll was called and quorum was established.

# 2. Review and Approve June 22<sup>nd</sup> 2020 DRAFT Agenda – VOTE

The June 22<sup>nd</sup> 2020 DRAFT Agenda was reviewed, amended and approved by consensus.

# 3. Review and Approve May 18th DRAFT Minutes - VOTE

#### 5. Public Comment

- Bill Hirsh spoke to the loss of Margot Antonetty. They worked together for 25 years. It is a terrible loss to the community.
- Wanda Vasquez spoke to collaboration with Jansen and HCPC. She is here for educational awareness. She is looking forward to collaboration.

#### 6. Council Staff Update

• CS Molnar spoke to the Door Dash credit. Everyone should've received a gift card for \$50. This is for two months, the next one will be sent out in August. These are parts of previously allocated funds for food.

### 7. SOA Update

- CM Andrews and Nikki Lacey provided the SOA and ADAP updates, including:
  - Strategy A: Improve Pre-Exposure Prophylaxis (PrEP) utilization
  - Strategy D: Improve Linkage to Care
  - Strategy J: Increase Rates of Insurance/Benefits Coverage for PLWH or on PrEP
  - Strategy L: Increase and Improve HIV Prevention and Support Services for People Who Use Drugs
  - Strategy N: Enhance Collaborations and Community Involvement
  - Strategy O: Further Leverage Existing Resources to Better meet the Needs of People at Risk for and Living with HIV in California
  - CM Lee-Miyaki asked if we have numbers around the amount of HIV positive folks who have tested positive for COVID.
    - CM Andrews does not have this information, but she will share with the group if she finds out.

#### 8. Micro-elimination

- Katie Burke, Jordan Akerley and Chris Toomey provided the HCV Update and overview of Micro-elimination strategies, including:
  - What is Micro-Elimination?
  - HIV/HCV Micro-Elimination in SF: Recommendations for Success
  - SFDPH Data- Based Strategies in HIV-HCV Coinfection
  - How HCV Surveillance Epi System is Set Up
  - Micro-elimination data process flow
  - Barriers/Challenges (Privacy concerns, data sharing, delays in getting current HCV numbers)
  - HCV Care Navigation
  - History of HCV Care Navigation at Shanti
  - HCV Care Navigation at Shanti (1-1 support from a care navigator, client led philosophy based in harm reduction, advocacy, navigating system of care)
  - Case Study
  - Case Study continued- Steps towards HCV Cure
  - Work with End Hep C and Community Partners
  - Lessons Learned (strong relationships with community partners, flexible service model, fieldwork and mobility, data-driven and client centered navigation)
  - HCV, COVID and Navigation Services

- CM Cooper spoke to retrieving medical records in the Tenderloin, and if this is in compliance with HIPPAA.
  - CS Molnar will forward this question to the presenters.

# 9. STI Update

- Stephanie Cohen provided the STD Update, including:
  - o Agenda
  - What happened to access to sexual health care during Shelter in Place (SIP)?
    - City Clinic and Magnet both reduced services when SIP went into place
    - Stopped asymptomatic STI screening
  - Data, 3 Time periods
  - o Sexual Health Services in the COVID-19 era
    - Routine STI and HIV screening remains a core element of prevention
      - Tele-health, home testing
  - Sex and COVID-19
  - HIV and COVID-19
- CM Bowman commented on the need for gender-inclusive language in the presentation.
- CM Knoble spoke to syphilis numbers in the community.
- CM Sullivan spoke to visitor restrictions at SROs during SIP, and how this may connect to reducing drug-induced spread of infection.
- CM Cabangun spoke to the concern of communities not returning to healthcare settings because of COVID.
  - Stephanie added that we need to examine the role of race in disparities and distrust in health care access, such as white folks coming back to clinics sooner than others.
- CM Chitty spoke to STD treatment at Kaiser.
