- CHEP Update by CM Knoble
 - ETE is going well. CHEP will host HIV counselor trainings for community based organizations.
 - Funds for COVID work went out a few weeks ago and applications are being reviewed and the announcement for winners will be released soon.
- HHS Report Update by CM Hutchcroft
 - COVID update through 11/27/2020: most impacted communities by COVID in San Francisco are Mission and Bay View—Hunters Point.
 - o HHS will host two online motivational interviewing sessions on 12/11/2020 and 12/18/2020.
 - o The Ryan White Part A annual application was submitted and there's a new HRSA project officer for ETE funding.
 - HHS is currently working on the NCC (Non-Competitive Continuation) Grant for ETE funding and anticipates an increase in funds in the second year but this isn't finalized until congress completes its budget process.
 - o HHS held its Annual ARIES meeting and the purpose was to prepare providers to submit their client data to HRSA.
 - Another RFP was released for non-medical case management in a residential setting.
- CPG Update by CM Hutchcroft
 - There were four days of CPG meetings hosted by Office of AIDS and they will host a team building holiday part on 12/10/20.
- CARE Update by CM Jewell and CM Blum
 - o 11/17/20 CARE Coalition held a post-election update and Q&A. CM Jewell reviewed the post-election analysis.
 - Fiscal year 2021 appropriations negotiations are still ongoing between congressional leaders.
 - o CARE Coalition Strategic Partnership with NACHO (National Association of County Health Officials) continues and more information will come as the discussions continue.
 - o CM Blum notes that the CARE Coalition is crafting a more robust request for Ryan White Part A and ETE funding.
- Membership Update by CS Molnar and CM Flores
 - Membership is underrepresented in youth and Latinx. If you know anyone that may be interested in membership please direct them to CS Jordan.
