Minutes

1. Call Meeting to Order and Roll Call. Introduction of Public. Co-Chair Welcome.

The meeting was called to order at 4:03 pm by CM Hutchcroft. Roll was called and quorum was established.

2. Review and Approve November 29th 2021 DRAFT Agenda – VOTE

The November 29th 2021 DRAFT Agenda was reviewed and approved by consensus.

3. Review and Approve October 25th 2021 DRAFT Minutes - VOTE

The October 25th 2021 DRAFT Minutes were reviewed and approved by consensus.

4. Announcements

- CS Molnar announced that there are no meetings scheduled for the month of December.
- CM Harkin announced that Thursday December 2nd, there will be data provided regarding overdoses in a meeting that will also be part of a call to action.
- CM Thomas reminded everyone that this Wednesday is World AIDS Day where a vigil and march will be held.

5. Public Comment

 Barbara Green-Ajufo informs the group about a survey where she is trying to reach out to folks and includes the information through chat.

6. General Updated

- CAEAR Coalition CM Jewell
 No Updates.
- HHS CM Hutchcroft

- CM Hutchcroft informs everyone that they are planning a February 2022 Harm Reduction Training. There is an elimination of annual Estimate of Unobligated Balance report submission for Ryan White Part A (RWPA).
- CHEP & CPG CM Thomas
 - o The mayor came out in support of the safe injection facility.
- SOA CM Kent
 - There has been an invitation sent out which can be found in the OA Voice.
- ADAP Nikki Gracev
 - o There are 152 clinics with a comprehensive list in the OA Voice.
 - CM Pearce highlighted that although for a lot of people the elimination of the 6-month recertification is beneficial, providers are now not able to maintain contact or check-in with folks as often now.
 - Gracey addressed this concern by letting everyone know that they are aware
 of this and are trying to plan for it.
 - CM Kent added that Part B are also working on an update for that elimination/ changes.
- ETE CM Sullivan
 - The online platform has training and resources. This meeting discussion involved lowbarrier referral processes. Community Health and Leadership Initiative is in the 8-week period and they have 12 mentors and have facilitated 8 trainings. There are facilitations and town halls that they will set up.

7. Membership Update - VOTE

CS Molnar updated the group that the Membership Committee approved Nga Le's application.
 Nga Le's membership was approved through consensus.

8. Getting to Zero

- Mary Lawrence Hicks presented on the Getting to Zero Update for San Francisco.
 - Populations of focus include: Black/ African American and Latino Residents, Homelessness/ Marginally housed, Persons over 60 years, Youth, PWUD, Trans and Cis Women, Persons with mental illness. They are focusing on rapid starts of treatment and rapid responses. Getting to Zero has centered on racial equity and justice.
 - World AIDS Day Consortium Meeting will be happening on December 2nd.
- Elizabeth Imbert discusses the Sub-committee on People Experiencing Homelessness and what they are going to try to do with this committee.
- Imbert highlights the rate of homelessness as well as who is getting tested and living with HIV.
 Only 20% of folks who are homeless are virally suppressed versus 71% of virally suppressed folks that are housed. She notes the lack of affordable housing, inability to meet subsistence needs, and access to supportive housing and case management. Their target metrics include zero new infections among PEH by 2025 and trying to create infrastructures of support.
 - Bill Hirsh notes the lack of resources, such as housing, being the underlying problem. He states that coordination can happen but if there are no resources, then nothing really happens.
 - CM Harkin addresses a convenience factor where they miss an appointment and are just written off and wishes there were still drop-ins where they can access care without such strict schedules.
 - Beth Neary mentions a QI initiative that addresses homelessness and getting to zero.

10. SCRT Program

- Kathleen Silk presents to the group on the Street Crisis Response Team.
 - The team follows key elements including identifying calls that will receive behavioral health and medical response rather than law enforcement response, deliver therapeutic de-escalation response, provide appropriate linkages and follow-up care. They currently go through police dispatch where calls get coded. They are 24/7 and city-wide. There have been no staff injuries, most crises are resolved in the community, low percentage of SCRT clients who need a 5150 hold.
