- CM Thomas noted how helpful it is to see data regarding overdoses in this report of people living with HIV.
- CM Mapp asked if the definition for what is HIV-related cancers has been reflected in this report? Is there any way to get more granular data about certain subgroups that are emerging? What is the current status of substance use and is there data for that?
 - Pipkin answered that they have not applied any new definitions to non-aids cancers in this report.
 - One example that Sharon shared regarding granular data is data of cis women that has been asked of them to share. Community members have shown concern for this group. She explains that this data is broken down in their presentation.
 - To answer the third question, Sharon explains that their data is limited by what they can find in medical chart reviews which means that the person has to be in care. This means that a medical setting has to record that substance abuse. Their continuing to grow their data of what current substance abuse looks like.
