1. Emergency Financial Assistance Grants:

The COVID 19 Emergency, increased need for Financial Assistance payments issued to third party providers related to housing, utilities, medical and other services have been significant. These grants are used to help RWPA eligible clients meet very basic living expenses, eviction prevention. This allocation would directly expand the number of available grants to clients without adding any additional administrative or programmatic expenses.

Allocation Amount provided in \$100 increments to 1000 clients

2. Food Security

The COVID=19 emergency also expanded the need for food delivery as clients are unable to venture outside their homes.

3. Client Incentive Vouchers:

HIV Health Services recommends provision of grocery store & farmer's market food vouchers and fast-food certificates to indigent homeless or marginally housed HIV-positive individuals who encounter nutritional deprivation due to the lack of food. These vouchers will also increase client access to services and assist them in getting necessary nutrition. Vouchers also serve to enhance client participation in program services. They will be used as incentives for clients to complete the finite steps of their individual service plans.

4. Reserve for future COVID 19 related expenses:

Though much remains unknown, previous respiratory epidemics have consistently involved a potentially significant second and often multiple waves of new infection and accompanying restrictions that impact mobility, employment and other pressures placed on PLWA clients. HHS believes this is a reasonable amount to hold in reserve to address those needs while balancing the need to provide direct and immediate help for current needs.
