HHS Administrative Updates

Funding

- **HHS submitted RWPA application for FY25/26** on 10/01/24.
 - This year's application is a competitive one.
- **HHS submitted RWP EHE application for FY25/26** on 10/22/24.
 - This year's application is a competitive one.
- **HRSA/HAB RWPA Site Visit** was held 8/6/24 – 8/9/24.
 - HRSA/HAB has not yet provided final report on site visit to HHS.
 - HHS will share planning body related commendations, fundings and improvement suggestions to HCPC at upcoming meeting.

HIV and Aging -City and County of San Francisco (CCSF) Cross Agency Collaboration

SF Interagency Collaboration on HIV and Aging Work Group consisting of HHS, Mayors Office of Housing and Community Development (MOHCD) and Disability and Aging Services (DAS) Office of Community Partnerships continues to meet monthly to identify and implement **opportunities for collaboration across programs to better serve HIV+ Elders and HIV+ People with Disabilities.**

- Cross Training line staff training among CCSF Departments
 - HHS will be providing a training for DAS staff and contract agencies on HIV system of care in November 2024.
 - HHS and MOHCD presented on HIV system of care and HIV housing services to the DAS Dignity Fund Oversight and Advisory Committee on 10/23/24.
 - DAS, LGBT Liaison, Maceo Persson speaking to HCPC at 11/25/24 meeting on LGBTQI services including HIV services.

HHS is working with HIV Integrated Services (HIVIS) with EHE funded technical assistance provided by CIS on a project **to ensure relinkage to care for people transitioning out of jail to the community.**

HHS with assistance from Facente Consulting with EHE funding has also **begun a project to identify ways to leverage emergency short term hotel based funded through HIV emergency grants to create pathways to longer term stable housing.**
