HIV Services (HHS) Director's Report HIV Community Planning Council Meeting July 28, 2025



City and County of San Francisco (CCSF) Budget Updates

- Mayor Lurie signed the City's budget for fiscal years 2025-26 into law on 7/24/25.
 - For several years, DPH's General Fund contribution has remained flat, while revenue has increased.
 - In the budget, DPH has committed to growing our revenue by more than \$400 million during the next two fiscal years to preserve vital services.

SF Department of Public Health Budget Updates

- Based on the Mayor's budget and priorities and to stay in balance, DPH is the process of realigning existing services and ensuring the prioritization of essential programs.
 - The budget includes another \$6.3 million in targeted reductions starting in FY 2025-26 and a further \$17 million in unallocated reductions in FY 2026-r27 community-based organizations (CBOs), which is slightly less than 10% of General Fund contracts.
 - The budget includes \$250K intended to backfill cuts to Ryan White Programs should they occur.
 - The budget also contains new investments in behavioral health services to build a more responsive system for treatment and recovery that addresses the challenges on the streets.
- SF DPH is also preparing for the shifting of the federal and state landscape with significant cuts to healthcare funding, including changes to Medicaid/Medi-Cal and the Affordable Care Act (ACA).
 - These changes in state and federal funding are expected to impact thousands of residents in San Francisco, particularly our undocumented communities.

HHS Funding Updates

- HHS received Part A Carryover NOA of \$518,112 on 7/28/25
- HRSA-HAB has not transmitted any additional notification of funding that provide additional information as to the total award for RWP funding.
 - HRSA HAB leadership has indicated that final notification of funding will be sent in the near future.
 - Immediately below is a chart detailing current known and projected funding for FY25-26 for SF EMA RWPA, SF DPH RWPB, RWPC, SF DPH RW EHE, SF DPH HHS General Fund (GF) and SF Getting to Zero (GTZ) GF.

following are clarifiers to projected funding in the chart above:

- Cuts could be made to EHE for the current fiscal year (3/1/25-2/28/26) and SF could have a reduction if the formula or top funding were to change.
- HHS has not yet received the total amount of the supplemental RWPA for the current fiscal year (3/1/25-2/28/26) so the projected \$200K short fall could increase or decrease
- As Ryan White Part B comes through the CA State Office of AIDS (SOA) and they have not yet received their complete NOF, if reduced SOA may reduce the amount of the award to SF for the current fiscal year and in the future
