SF Department of Public Health Budget Updates

- Director Tsai announced that due to budget shortfalls, DPH is reducing GF contracts \$17M effective 07/01/26
 - No reductions proposed to HIV direct care services
 - Proposed reductions
 - UCSF: \$5.8M (1.6%*)
 - Reductions to hospital clinical spending from maximizing revenue offsets, limiting cost inflation and bringing a program in house to be done with DPH staff
 - CBO and Staff Capacity Building, Training and Consulting Services: \$5.2M
 - Eliminate all funding for CBO and DPH training/workforce development, capacity building and consulting services that are not required by regulation
 - Vocational Programs: \$1.7M
 - Reduce vocational training programs to find operational efficiencies
 - Other Reductions: \$4.2M
 - Reductions across a variety of services reflecting funding updates and updated services requirements

- Mayor Lurie has directed SF DPH to identify \$50M in reductions effective 07/01/26
 - Timeline
 - Departments Present Budget Proposals 02/02/26
 - Departments submit to Controllers and Mayor 02/21/26
 - Mayoral Review March and April
 - Mayor Finalizes Budget 06/01/27

HHS Updates

- Effective 03/01/26, HRSA DHHS is implementing a new formula allocation for RWPA and RWPB based on Using Most Recent Address Data replacing address at time of initial HIV diagnosed will significantly negatively impact San Francisco EMA as well as California State Office of AIDS
