7. Demographic Information Update

- CS Perez shares the EPI demographic update. She notes there was one change due to a Council Member leaving the Council, which leaves our total number of Council Members at 28. The departure of the Council Member affected the Latino/a/x demographics.
- CS Perez shares the ARIES demographic update. She notes the same change for the Latino/a/x demographic due to a Council Member leaving the Council. She highlights the Council is also underrepresented for males.
 - o CM Knoble asks where nonbinary folks fall in the Gender category.
 - CS Perez says they fall within the "Unknown" category.
 - CM Arnold says he wants to refer his Program Manager at the Black Health Center of Excellence and asks if that's allowed.
 - CS Perez says he is more than welcome to refer folks to apply. She says the only issues they
 may run into is that the Council is overrepresented for Providers, but they are not currently
 at a place where they're freezing applications from Providers.
 - CM Reina Hernandez asks how they take into account other HRSA mandated categories such as systems impacted folks.
 - CS Perez highlights the demographics that are tracked on the EPI and ARIES demographics updates – mainly race, gender, and age.
