- CS Perez shares the ARIES demographic report. She notes the new Council Member positively affected the Latino/Hispanic demographic numbers, as well as the non-aligned consumers.
  - CM Ron Hernandez highlights the non-aligned consumer numbers for Asian is incorrect, noting it should be two members.
    - CS Perez will make the adjustment.
  - CM Guillen asks what the difference is between aligned and non-aligned consumers.
    - CS Perez clarifies the difference between the two.
  - CM Arnold asks if the HCPC is looking for both Black/African American consumers and providers, or
    just one or the other.
    - CS Perez says ideally they are looking for consumers, but the Committee hasn't decided to pause applications from providers.
  - CM Soto asks if there's a way to track consumers of prevention services as well.
    - CS Perez says they are not currently tracking prevention service users, but will bring it up with CS Molnar.
  - CM Guillen asks if Council Members can help with recruitment for the HCPC.
    - CS Perez says word of mouth from Council Members can be the most impactful.
      - CM Ron Hernandez says they often rely on Council Members to be recruiters.
