Minutes

1. Introductions

The meeting was called to order at 3:03 pm by CM Ron Hernandez. Everyone introduced themselves and quorum was established.

2. Review /Approve September 5th, 2024 DRAFT Agenda – VOTE

The September 5th, 2024 DRAFT Agenda was reviewed and approved by consensus.

3. Review / Approve August 8th, 2024 DRAFT Minutes – VOTE

The August 8th, 2024 DRAFT Minutes were reviewed and approved by consensus.

4. Announcements

- CS Molnar announces that this month's Full Council meeting will be the Resource and Prioritization Allocation meeting.
- CS Molnar announces the renewing Council Members received their appointment letters from the Mayor's office. They are still waiting for appointment letters for the new Council Members.

5. Public Comment

6. Resource Allocation – VOTE

- CS Molnar reviews the Resource Allocation motions on the floor, starting with the flat funding scenario.
 CS Molnar notes there is already a motion on the floor so this does not need to be moved or seconded, and will be done via a roll call vote.
 - o Flat Funding: If funding remains at the current level, service category resource allocation will remain level across all categories.

Motion to approve the flat funding scenario passes through a roll call vote, refer to column (3).

- CS Molnar reviews the increased funding scenario. He highlights that there was an update from last year's increased funding motion so that it more closely parallels the decreased funding scenario.
 - Increased Funding: If increased funding occurs, service category allocation will be increased proportionally across all service categories not covered under California's essential health benefits package.

Motion to approve the increased funding scenario passes through a roll call vote, refer to column (4).

- CS Molnar reviews the decreased funding scenario.
 - Decreased Funding: In the event of decreased funding, for the first 10% of reductions,
 allocation for services that are covered under California's essential health benefits package will

be reduced proportionally. If further reduced allocation is required, reductions will occur proportionally across all service categories.

Motion to approve the increased funding scenario passes through a roll call vote, refer to column (5).

 - Marco Montenegro The group interviewed the candidate and discussed whether to approve the potential new member.
 - CM Ron Hernandez notes he likes the applicant's energy.
 - CM Soto notes that the applicant is a provider, but speaks to his interest and background in serving the Council's focus populations.

- CS Perez shares the ARIES demographic update.
 - O CM Knoble inquires about the numbers for Latino/a/x and how the new members will impact those numbers. They ask if adding three new Latino/a/x Council Members will be too many.
 - CS Molnar notes the HCPC may lose CM Cadabes, which would change the numbers. He
 highlights that if all three new applicants are approved for the Council, they would be
 adding two folks in that demographic category. He highlights they are currently
 underrepresented with the Latino/a/x community.
 - CM Lee-Miyaki notes that with the increase in new HIV infections in the Latino/a/x community that adding more representation would be a good idea.
 - CM Soto asks about recruitment for youth and inquires if there were ever any responses from the outreach they did with youth organizations.
 - CS Molnar notes they did hear back and he had three people reach out to him. He responded to them and has tried following up with them, but has yet to hear back.
 - CM Lee-Miyaki says he is going to be speaking to the Public Health students at San Francisco State to see if he can garner any interest there.
